Initial sales are on advance payment basis and depending on payment record and volumes of sales, credit limit of 25/30 days sale is considered (liable for cancellation in case of payment delays /default). In the event of non-payment the amount may be turned over to a collection agency or attorney for collection.

In the event of non-payment the amount may be turned over to a collection agency or attorney for collection. Reasonable collection fees and/or attorney's fees prior to and at trial and in any appellate or bankruptcy proceeding plus all court and attendant collection costs are to the dealer's account.

Should the account balance exceed any established Credit Limit, Applicant liability for payment extends to the entire account balance. Company has the right to reduce the Credit Limit and/or withdraw credit from Applicant under the credit agreement at any time without prior notice, except as otherwise provided by law.

- 3. If any provision contained in the Dealership arrangement is determined by a court to be in conflict with applicable law, that provision shall be considered changed or omitted to conform to such law; all other provisions of this credit agreement remain in full force and effect. Nothing in this credit agreement shall be deemed to limit WTPPL collection rights or remedies.
- 4. The Applicant hereby acknowledges and agrees to all terms and conditions including Credit Application and the credit agreement included herein, and to the invoice terms for the sale of products.

5. Trade Marks & Brand Names:
